



**EXECUTIVE ORDER NO. 2023- 032**

**CONSTITUTING THE TECHNICAL WORKING GROUP FOR THE  
FORMULATION OF THE NAGA CITY FOREST LAND USE PLAN  
FOR CY 2023-2033**

**WHEREAS**, the Constitution provides for the protection and advancement of the right of the people to a balanced and healthy environment in accord with the rhythm and harmony of nature;

**WHEREAS**, in accordance thereto, Executive Order No. 318, series of 2004, mandates national government agencies to assist local government units in incorporating forest land use plans in the comprehensive land use plans;

**WHEREAS**, the City Government of Naga and the Department of Environment and Natural Resources have entered into an agreement this 2023 to partner in the drafting of the Naga City Forest Land Use Plan for Calendar Years 2023-2033;

**WHEREAS**, there is a need to identify the individuals who will be constituting the city's Technical Working Group for the formulation of the Naga City Forest Land Use Plan for CY 2023-2033;

**NOW, THEREFORE, I, NELSON S. LEGACION**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. TECHNICAL WORKING GROUP.** The city's Technical Working Group for the formulation of the Naga City Forest Land Use Plan for CY 2023-2033 (TWG – FLUP 2022-2033) is hereby constituted, with the City Environment and Natural Resources Officer as the chairman thereof and with the following individuals as members:

*A) Institutional Sector*

1. City Administrator
2. Chairman, SP Committee on Environment and Energy
3. Punong Barangay, Barangay Panicuason
4. Head, City Human Resource Management Office
5. Head, City Events, Protocol and Public Information Office
6. Head, Internal Audit Service

1. Head, City Agriculturist's Office
2. Executive Director, Naga City Investment Board
3. Head, Metro PESO
4. Head, Tourism Office

*D) Infrastructure and Physical Sector*

3. Head, City Assessor's Office

*E) Resilient Urban Planning Sector*

1. Head, City Planning and Development Office

3. Head, City Disaster Risk Reduction and Management Office

**SECTION 2. FUNCTIONS.** The Technical Working Group is hereby tasked to:

- a. Conduct sectoral and inter-sectoral analysis, validation and reports;
- b. Hold surveys, consultation meetings, workshops and other activities that will help in the formulation of the Forest Land Use Plan and will facilitate acceptance or approval of the same;
- c. Integrate and finalize studies, research findings and consultation outputs; and,
- d. Perform all other functions that are necessary in the crafting and approval of the Naga City Forest Land Use Plan for CY 2023-2033

**SECTION 3. SECRETARIAT.** The City Environment and Natural Resources Office shall serve as secretariat to the TWG-FLUP 2023-2033. It shall provide assistance in administrative and technical matters.
