CREATING THE NAGA CITY ANTI-DRUG ABUSE TASK FORCE

WHEREAS, the Local Government of Naga City recognizes the ill effects of drugs on its constituents and on the society, in general;

WHEREAS, a strategic, coordinated and multi-sectoral approach against illegal drugs will not only curtail its supply but will also lead to less crimes in Naga;

WHEREAS, all stakeholders must be on board in the war against drugs as a success in this campaign will definitely generate more investment in Naga, foster peace and order, and create a healthy, self-reliant and caring society for all Nagueños;

NOW, THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION OF THE NAGA CITY ANTI-DRUG ABUSE TASK FORCE. The Naga City Anti-Drug Abuse Task Force is hereby established, with the following composition:

Chairman, SP Committee on Peace & Order
and City Councillor

Members:

- City Director, Naga City Police Office
- Provincial Director, Philippine Drug Enforcement Agency – Camarines Sur
- District Officer, National Bureau of Investigation – Naga District Office
- Force Commander, Naga City Mobile Force Company
- Executive Director, Naga City Dangerous Drugs Board
- Department Head, Public Safety Office

SECTION 2. DUTIES AND RESPONSIBILITIES. The Naga City Anti-Drug Abuse Task Force has the following tasks:

- 1) Gather intelligence and information about drug dealers and drug users in the city;
- 2) Create and operate an enforcement team to apprehend violators of Republic Act No. 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, as amended;
- 3) Cause the launch of raids and other operations against identified targets;

- 4) Cause, coordinate, support and implement anti-drug abuse operations and programs in Naga City; and,
- 5) Perform other tasks as needed to make Naga City a healthy, liveable and drug-free city.


SECTION 3. MEETINGS. The Task Force shall meet at least once a month and as deemed necessary by the Chairperson.

In all these meetings, the members of the Task Force must be personally present. Given the sensitive nature and urgency of this matter, no representative shall be allowed.


SECTION 4. PROGRESS REPORT. The Task Force shall report to the City Mayor the progress of their projects, activities and programs at least once a month.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately.
