**RECONSTITUTING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN TEAM
OF THE CITY OF NAGA**

WHEREAS, Executive Order 2018-020 mandates the creation of the Local Public Transport Route Plan Team of the City of Naga;

WHEREAS, the LPTRP Team was created in reference to Department Order No. 2017-011 or the "Omnibus Planning and Identification of Public Road Transportation Services and Franchise Issuance" of the Department of Transportation (DOTr) which recognizes the subsidiarity principle that LGUs are in a better position to identify local public transport service requirements and formulate plans for improving connectivity between and among their urban and rural socio-economic activities;

WHEREAS, in view of the current changes in the personnel of the city government, there is a need to update the composition of the Local Public Transport Route Plan Team;

NOW, THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION. The Local Public Transport Route Plan Team of Naga shall be composed of the following:

- Chairman: City Mayor
- Vice Chairman: Chairperson, SP Committee on Public Utilities
- Members:
 - Head, Public Safety Office
 - Head, City Planning and Development Office
 - Head, City Engineer's Office
 - Head, City Agriculturist's Office
 - Head, Investment and Tourism Promotions Office
 - Head, Sangguniang Panlungsod Secretariat

SECTION 2. EXPANDED MEMBERSHIP. The representatives of the following institutions are hereby invited to be part and become members of the Local Public Transport Route Plan Team of Naga:

- Bicol State College of Applied Science and Technology
- Pinagkaisang Samahan ng mga Tsuper at Operators Nationwide
- Philippine National Police
- Liga ng mga Barangay
- Department of Public Works and Highways – 3rd District of Camarines Sur
- Land Transportation Office
- Representative from LTFRB
- Land Transportation Franchising and Regulatory Board
- Academe

SECTION 3. DUTIES AND RESPONSIBILITIES. The Team is hereby tasked to:

1. Prepare the Local Public Transport Plan (LPTRP) based on and/or consistent with the Manual provided by DOTr;
2. Submit the aforementioned plan to the Land Transportation Franchising and Regulatory Board for review, copy furnished the Department of Interior and Local Government, within six months from the formal notice of the DOTr.
3. Conduct yearly monitoring of the implementation of the LPTRP; and,
4. Update and revise the LPTRP as needed.

SECTION 4. SECRETARIAT. The City Planning and Development Office shall serve as the Secretariat of the Local Public Transport Route Plan Team of Naga.

SECTION 5. FUNDING. The City Planning and Development Office shall incorporate in its budget the necessary funds for the efficient and proactive operations of the Team.
