## CREATING THE TASK FORCE FOR THE COMPREHENSIVE PROGRAM FOR STREET CHILDREN, STREET FAMILIES, AND INDIGENOUS PEOPLES (COMPRE) IN NAGA CITY

WHEREAS, the Department of Social Welfare and Development (DSWD) developed the Comprehensive Program for Street Children, Street Families, and Indigenous Peoples, especially Sama-Badjaus (COMPRE), as an integrated approach and a package of services and interventions to address the needs of those at-risks in the streets;

WHEREAS, the program desires to reduce activities and vulnerabilities of children and families at risks in the streets by responding to their immediate needs and engaging them in productive cultural and developmental activities in a safe environment;

WHEREAS, the City Government of Naga has been chosen by the DSWD as one of the expansion areas for the replication of said program;

WHEREAS, LGU-Naga and the DSWD has sealed the said undertaking through a Memorandum of Agreement;







## SECTION 2. FUNCTIONS. The NCTFC shall have the following functions:

- 1. Formulate and implement plans to address issues concerning children, families, and IPs in street situations;
- Conduct advocacy activities to increase awareness and strengthen community-based response on children, families, and unattached adults atrisks in the streets;
- 3. Mobilize community participation and pooling of resources;
- 4. Lead the conduct of out-reach activities; and
- 5. Assist in the provision of protective services including case management programs and follow-up activities.

**SECTION 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
