

CREATING A STEERING COMMITTEE FOR THE MONTH-LONG SUPPLEMENTAL IMMUNIZATION ACTIVITY THIS MAY 2023

WHEREAS, Republic Act No. 10152 provides for the mandatory basic immunization of children;

WHEREAS, to implement the said law, the Department of Health has issued Department Memorandum No. 2022-0585 providing for interim guidelines in the implementation of CY 2023 Measles Rubella and bivalent Oral Poliovirus Vaccine Supplementary Immunization Activities;

WHEREAS, among those provided in the guidelines is the conduct of DOH of a nationwide immunization campaign to 0-59 month-old children to control polio and stop any measles outbreak;

WHEREAS, from May 1 to 31, 2023, there will be a month long Measles Rubella and Bivalent Oral Polio Vaccine Supplemental Immunization Activity;

WHEREAS, it is paramount for the City Government of Naga to support the aforesaid undertaking and join the national government in attaining the target of having 95% of fully immunized children;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. STEERING COMMITTEE FOR THE MONTH-LONG SUPPLEMENTAL IMMUNIZATION ACTIVITY. The Steering Committee for the Month-Long Supplemental Immunization Activity is hereby created, with the City Health Officer as lead and with the personnel as members:

- Representative, City Events, Protocol and Public Information Office
- Representative, City Social Welfare and Development Office
- Representative, City Population and Nutrition Office
- Representative, City Disaster Risk Reduction and Management Office
- Representative, Persons with Disability Affairs Office
- Representative, Ginhawang Nagueño Program
- Representative, Naga City Council for Women
- Representative, Bantay Familia
- Representative, Solo Parents Association
- Representative, Naga City Children's Affairs Office
- Representative, Naga City QUEEN Program
- Representative, Naga City Dangerous Drugs Board





- Representative, Sangguniang Kabataan Federation
- Representative, Liga ng mga Barangay
- Representative, Naga City People's Council

SECTION 2. FUNCTIONS AND RESPONSIBILITIES. The Steering Committee shall have the following functions and responsibilities:

- a. Formulate, plan and implement appropriate programs and activities for the successful observance of the month-long supplemental immunization activity;
- b. Ensure the active participation of all concerned during the aforesaid month-long activity, especially the barangay officials, barangay health workers and the target beneficiaries; and,
- c. Promote awareness on the nature of polio and measles, the need for immunization and the consequences on failure to attain the national target of 95% fully immunized children; and,
- d. Perform such other incidental and necessary functions in accordance with this Executive Order.

SECTION 3. COOPERATION OF BARANGAY OFFICIALS, EMPLOYEES AND VOLUNTEERS. All Barangay officials, employees and volunteers are enjoined to assist, inform and encourage our constituents, the Nagueños, to support and participate in the month long Measles Rubella and Bivalent Oral Polio Vaccine Supplemental Immunization Activity this May 1-31, 2023.

Barangay Halls or Barangay Health Stations and other possible vaccination sites must be made available for this undertaking.

All barangay personnel shall be fully mobilized for the successful implementation of this month-long activity.

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
