WHEREAS, the Entity is desirous that the Contractor execute Drainage and Cross-Drainage at 5th and Hilda Sts., Villa Sorabella Subd., Bgy. Concepcion Grande, Naga City, Contract Reference Number: 008002-2023-04 (hereinafter called "the Works") and the Entity has accepted the Bid for One Million Eight Hundred Twenty One Thousand Four Hundred Twenty Seven & 25/100 (P 1,821,427.25) Pesos by the Contractor for the execution and completion of such Works and the remedying of any defects therein. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS: assigned to them in the Conditions of Contract hereinafter referred to.

In this Agreement, words and expressions shall have the same meanings as are respectively

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation?
