

Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised the Invitation to Bid for the Drainage, Cross-Drainage and Road Concreting at Jolly Neighbors (continuation), Bgy. Sta. Cruz, Naga City, Contract Reference Number: 008283-2023-04, in the City Government of Naga's website (www.naga.gov.ph), the PhilGEPS and at conspicuous places at the premises of the City Hall continuously for 7 days from May 26 to June 2, 2022;

WHEREAS, in response to the said advertisement, three (3) interested bidders purchased bid documents;

WHEREAS, three (3) bids were submitted on June 5, 2022 and two (2) passed the preliminary examination of bids, as follows;

CONTRACT AGREEMENT

THIS AGREEMENT, made this 3rd day of July, 2023, between City Government of Naga, Naga City, Philippines (hereinafter called the "Entity") and MNZ Builders of #22 Bernardo's Compound, Bgy. Sta. Cruz, Naga City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Drainage, Cross-Drainage and Road Concreting at Jolly Neighbors (continuation), Bgy. Sta. Cruz, Naga City, Contract Reference Number: 008283-2023-04 (hereinafter called "the Works") and the Entity has accepted the Bid for Two Million One Hundred Ninety Thousand Eight Hundred Thirty One & 64/100 (P 2,190,831.64) Pesos by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:


- a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Two Million One Hundred Ninety Thousand Eight Hundred Thirty One & 64/100 (P 2,190,831.64) Pesos or such other sums as may be ascertained, MNZ Builders agrees to Construct the Drainage, Cross-Drainage and Road Concreting at Jolly Neighbors (continuation), Bgy. Sta. Cruz, Naga City, in accordance with his/her/its Bid.
4. The City Government of Naga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

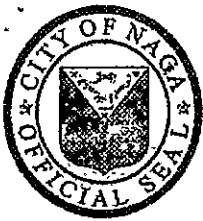
