Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- In consideration for the sum of One Million Ninety Four Thousand Eight Hundred Ninety Seven & 24/100 (P 1,094,897.24) Pesos or such other sums as may be ascertained, BELJUN Construction And Engineering agrees to Construct the Drainage and Cross-Drainage at Zone 5 Urban Poor c/o Mean Caspi, Bgy. Igualdad, Naga City, in accordance with his/her/its Bid.
- The City Government of Naga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


