





CONTRACT AGREEMENT

THIS AGREEMENT made the 03 JUL 2023 day of _____, 2023 between the City Government of Naga, Naga City, Philippines (hereinafter called "the Entity") of the one part and Global Excellence Motors, Inc. of Block 15 FGC Bldg., Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of 3 Units Brand New Pick-up Trucks/Patrol Vehicles** (a republication after a failed bidding) for public safety patrol, traffic management and ordinance enforcement, **Project/ Contract Reference Number: 2023-017** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Four Hundred Twenty Six Thousand (Php 3,426,000.00) Pesos** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Three Million Four Hundred Twenty Six Thousand (Php 3,426,000.00) Pesos** or such other sums as may be ascertained, **Global Excellence Motors, Inc.** agrees to supply and deliver the 3 Units Brand New Pick-up Trucks/Patrol Vehicles in accordance with his/her/its Bid.
4. The *City Government of Naga* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


