2. The City Government of Naga now invites bids for the above Procurement Projects. Completion of the Works is required within the stated contract duration. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from City Government of Naga at the address given below from 8:00AM to 5:00PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on May 26 to June 19, 2023 from the BAC Secretariat, Room 208, Second Floor, City Hall Building, City Hall Compound, Brgy. Concepcion Pequena, upon payment of the applicable fee for the Bidding Documents.

Contractors/applicants who wish to participate in this procurement shall submit their Bidder's Registration Form and register at the BAC Secretariat, while those who are already enrolled shall keep their records current and updated.

- Prospective bidders shall present their ORIGINAL OFFICIAL RECEIPT OF PAYMENT for Bidding Documents (project-specific) to the BAC Secretariat before the deadline of bid submission. Only the OWNER or AUTHORIZED REPRESENTATIVE as reflected in the Bidder's Registration Form will be allowed to transact business relative to the bidding matters. Thus, said owner or authorized representative is required to present two (2) government-issued IDs for identification purposes.
6. The City Government of Naga will hold a Pre-Bid Conference on Tuesday, June 6, 2023, 3:00PM at the City Procurement Office, Ground Floor, City Hall Building, City Hall Compound, Naga City, which shall be open to prospective bidders.
 7. Bids must be duly received by the BAC Secretariat through manual submission at BAC Secretariat, Room 208 Second Floor, City Hall Building, City Hall Compound on or before 9:00AM on Monday, June 19, 2023. Late bids shall not be accepted.
 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instructions to Bidders (ITB) Clause 15.
 9. Bid opening shall be on Monday, June 19, 2023, 10:00AM at the City Procurement Office, Ground Floor, City Hall Building, City Hall Compound. Bids will be opened in the presence of the bidder-owners or of their duly authorized representatives who choose to attend the activity.
 10. Additional information:
 - a) An Annual Registration Fee of Three Thousand (P 3,000.00) Pesos is required. The owner, in case of sole proprietorship, or the Authorized Managing Officer, in case of corporation, must be present during the process of the annual registration of his/her firm.
 - b) Forms in the PBD should be used in submitting proposals and should remain unaltered.
 - c) Prospective Bidders are strongly encouraged to order or download the electronic copy of the Bidding Documents from the PhilGEPS website, for them to be included in the Document Request List (DRL) of the project.
 11. The City Government of Naga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
