THIS AGREEMENT made the City, Philippines (hereinafter called "the Entity) of the one part and JKP2 safety And Security Products of #7 Nazareno Building, Taal St., Bgy. Balatas, Naga City, here nafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of 2 Units Emergency Response Ambulance (Type I) (a republication after a failed bidding), for use during emergency response, transporting patients and response vehicle during trauma emergencies, Project/Contract Reference Number: 2023-026 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Four Million Five Hundred Seventeen Thousand Seven Hundred Seventy Six (Php 4,517,776.00) Pesos (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
