AUTHORIZING THE INSTALLATION OF A LOCAL HISTORICAL MARKER TO UNIVERSIDAD DE STA. ISABEL DE NAGA:-

WHEREAS, preserving and promoting the historical and cultural heritage of our city is of utmost importance in recognizing the contributions and milestones of our local institutions;

WHEREAS, Section 16 of Republic Act No. 7160 states that, every Local Government Unit within their territorial jurisdiction, shall exercise the power to essentially promote the general welfare of ensuring and promoting the preservation and enrichment of culture;

WHEREAS, Universidad de Sta. Isabel de Naga has been a pillar of education and learning in our city for over a century, playing a significant role in shaping the intellectual and social landscape of our community;

WHEREAS, it is essential to commemorate the rich history of Universidad de Sta. Isabel de Naga and its invaluable contributions to the growth and development of our city;

WHEREAS, the installation of a local historical marker will serve as a tangible reminder of the institution's historical significance and inspire pride in our citizens, visitors, and future generations;

NOW, THEREFORE, I, Mayor Nelson S. Legacion, by virtue of the powers vested in me by law as the Mayor of Naga City, do hereby order and authorize the installation of a local historical marker to commemorate Universidad de Sta. Isabel, subject to the following provisions:

Section 1. Establishment of the Local Historical Marker. A local historical marker shall be designed, created, and installed at a prominent and easily accessible location within the premises of Universidad de Sta. Isabel by the City Events, Protocol and Public Information Office in consultation with the institution's administration.

The historical marker shall contain relevant historical information about Universidad de Sta. Isabel, such as its founding date, notable achievements, significant personalities associated with the institution, and any other details deemed necessary to provide a comprehensive overview of its historical significance. The text of historical marker shall form part as "Annex A" of this Executive Order.

Section 2. Funding and Implementation. The funds necessary for the creation, installation, and maintenance of the historical marker shall be allocated from the budget of the City Events, Protocol and Public Information Office.

The CEPPIO, in coordination with the administration of Universidad de Sta. Isabel, shall be responsible for overseeing the implementation of this Executive Order. They shall establish a project timeline and ensure the marker's installation within a reasonable period.

Section 3. Public Awareness and Engagement. The CEPPIO, in collaboration with the Universidad de Sta. Isabel, shall develop a communication plan to raise public awareness about the historical marker's significance, unveiling ceremony, and related events. The Universidad de Sta. Isabel is encouraged to organize educational programs, seminars, and exhibits to promote the historical marker and further educate the public, particularly the students, about the institution's history and its impact on our city.

Section 4: Effective Date. This Executive Order shall take effect immediately upon its issuance.
