**AUTHORIZING THE INSTALLATION OF A LOCAL HISTORICAL
MARKER TO NAGA COLLEGE FOUNDATION:-**

WHEREAS, recognizing and commemorating the historical significance of local institutions is crucial in preserving our city's cultural heritage and fostering a sense of pride among its residents;

WHEREAS, Section 16 of Republic Act No. 7160 states that, every Local Government Unit within their territorial jurisdiction, shall exercise the power to essentially promote the general welfare of ensuring and promoting the preservation and enrichment of culture;

WHEREAS, the Naga College Foundation has been a prominent educational institution in our city for several decades, contributing significantly to the development of education, research, and community engagement;

WHEREAS, it is essential to honor and celebrate the achievements and milestones of the Naga College Foundation, acknowledging its vital role in shaping the intellectual and social landscape of our community;

WHEREAS, the installation of a local historical marker will serve as a tangible symbol of the institution's rich history, inspiring current and future generations to appreciate its contributions;

NOW, THEREFORE, I, Mayor Nelson S. Legacion, by virtue of the powers vested in me as the Mayor of Naga City, do hereby order and authorize the installation of a local historical marker to commemorate the Naga College Foundation, subject to the following provisions:

Section 1. Establishment of the Local Historical Marker. A local historical marker shall be designed, created, and installed at a prominent and easily accessible location within the premises of Naga College Foundation by the City Events, Protocol and Public Information Office in consultation with the institution's administration.

The historical marker shall contain relevant historical information about Naga College Foundation, such as its founding date, notable achievements, significant personalities associated with the institution, and any other details deemed necessary to provide a comprehensive overview of its historical

significance. The text of historical marker shall form part as "Annex A" of this Executive Order.

Section 2. Funding and Implementation. The funds necessary for the creation, installation, and maintenance of the historical marker shall be allocated from the budget of the City Events, Protocol and Public Information Office.

The CEPPPIO, in coordination with the administration of Naga College Foundation, shall be responsible for overseeing the implementation of this Executive Order. They shall establish a project timeline and ensure the marker's installation within a reasonable period.


Section 3. Public Awareness and Engagement. The CEPPPIO, in collaboration with the Naga College Foundation, shall develop a communication plan to raise public awareness about the historical marker's significance, unveiling ceremony, and related events. The Naga College Foundation is encouraged to organize educational programs, seminars, and exhibits to promote the historical marker and further educate the public, particularly the students, about the institution's history and its impact on our city.

Section 4: Effective Date. This Executive Order shall take effect immediately upon its issuance.
