

Resolution Declaring LCRB and Recommending Approval

Calauag, Naga City, Contract Reference Number: 008854-2023-04**, in the City Government of Naga's website (www.naga.gov.ph), the PhilGEPS and at conspicuous places at the premises of the City Hall continuously for 7 days from July 13 to 20, 2022;



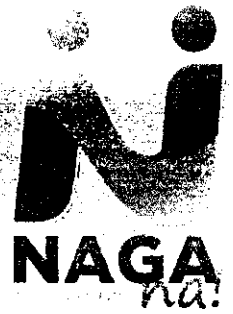

CONTRACT AGREEMENT

This AGREEMENT made this 01 day of SEP 2023 between City Government of Naga, Naga City, Philippines hereinafter called the "City" and Nolcast Construction And Supply of 2100 East Street Bgy. Calauag, Naga City hereinafter called the "Contractor".

With effect from the date of execution of this Agreement, the Contractor, to wit: Storm Drainage at Phase 1 St. Vincent and Vilmar to Karangahan Creek, Bgy. Calauag, Naga City, Contract Reference Number 008854-2023-04. It is to be noted that the Work, and the City has accepted the bid for Three Million One Hundred Eighty Three Thousand Eight Hundred Seventy Four & 83/100 (P 3,183,874.83) Pesos or such other sums as may be required to construct and complete the work and the contractor agreed to perform the same.

NOTICE TO AWARD AND AGREEMENT WITHIN USE THEREOF (N/A)
