day of THIS AGREEMENT made the , 2023 between the City Government of Naga, Naga City, Philippines (hereinafter called "the Entity") of the one part and G.D. Abad General Merchandise of Zone 6, Panganiban Drive, Bgy. Concepcion Pequeña, Naga City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Electrical Materials (1 lot) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Eighty Seven Thousand (Php 1,087,000.00) Pesos (hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
