THIS AGREEMENT, made this <u>7 0 0CT 2003</u> of <u>NTOBER</u>, 2022 between City Government of Naga, Naga City, Philippines (hereinafter called the "Entity") and MDQR Construction And Supply of Lot 25, Block 15, 4th St., Parkview Village, Bgy. San Felipe, Naga City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Rehabilitation of Drainage and Concreting of Shoulder at Magnolia St., Bgy. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Four Hundred Seventy Nine Thousand Two Hundred Fifty Five & 51/100 (P 479,255.51) Pesos or such other sums as may be ascertained, MDQR Construction And Supply agrees to Construct the Rehabilitation of Drainage and Concreting of Shoulder at Magnolia St., Bgy. Bagumbayan Sur, Naga City, in accordance with his/her/its Bid.
- 4. The City Government of Naga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
