Bid Bulletin: Amendments to Bid Documents for the Supply and Delivery of Medicines for Naga City Hospital and City Health Office I and II

Date: July 31, 2023

This bid bulletin is issued to provide important updates and revisions to the bid documents for the projects mentioned below:

Project Reference No. 2023-031: Supply and Delivery of Medicines (Lots 1 to 3) for Naga City Hospital

The following items have been removed from the bid:

- 1) Lot 1, Item No. 16
- 2) Lot 1, Item No. 25
- 3) Lot 2, Item No. 23
- 4) Lot 3, Item No. 23

The above items are regulated drugs, and due to the complexity involved in their acquisition, they are excluded from the items for bid.

Furthermore, the Approved Budget for the Contract (ABC) for each lot has been adjusted as follows:

- 1) Lot 1 ABC: Changed from P 1,514,444.50 to P 1,475,166.50. The cost of bid documents remains unchanged.
- 2) Lot 2 ABC: Changed from P 2,107,340.80 to P 2,094,840.80. The cost of bid documents remains unchanged.
- 3) Lot 3 ABC: Changed from P 1,890,606.50 to P 1,879,828.00. The cost of bid documents remains unchanged.

Project Reference No. 2023-032: Supply and Delivery of Medicines (Lots 1 to 3) for City Health Office I and II

The following corrections have been made to the items for bid:

- 1) Lot 1, Item No. 4: Corrected to "Amoxicillin 100mg/ml granules/powder for drops (suspension) 10ml (as trihydrate): ORAL"
- 2) Lot 1, Item No. 55: Corrected to "Ketoconazole 20g/g: Cream"
- 3) Lot 1, Item No. 72: Corrected to "Zinc (Equivalent to 20mg elemental zinc/ml) Syrup; 60ml (as sulfate monohydrate)"
- 4) Lot 2, Item No. 7: Corrected to "Insulin Glargine (Solostar Pen)"
- 5) Lot 2, Item No. 10: The preferred brand to match with current stocks is "SPEEDA."
- 6) Lot 3, Item No. 1 and 2: "Oral Powder Solution" should be considered similar to granules.
- 7) Lot 3, Item No. 18: The unit should be "capsule."

- 8) Lot 3, Item No. 19: Corrected to "Cotrimoxazole 200mg/40/5ml Suspension"
- 9) Lot 3, Item No. 20: Corrected to "Colchicine 500mcg."

Project Reference No. 2023-034: Supply and Delivery of Medicines (1 lot) for Naga City Hospital

The following preferences have been made for specific items:

- 1) Lot 1, Item No. 2: The preferred brand is "EQUIRAB."
- 2) Lot 1, Item No. 5: The preferred brand is "SPEEDA."

Other Important Information:

- 1) The FDA Certificate of Product Registration (CPR) attached in the bid documents should match the actual delivery.
- 2) All drugs and medicines should have a minimum shelf life of 18 months.

Bid Opening Information: The bid opening date remains unchanged and will be held on Monday, 14th August 2023, at 3:00 PM. The venue for the bid opening is the City Procurement Office, Ground Floor, City Hall Building, City Hall Compound. Bids will be opened in the presence of bidders' representatives who choose to attend the activity.

This bid bulletin, labeled as Supplemental/Bid Bulletin No. 1, forms an integral part of the original Bidding Documents. Any provisions in the original Bidding Documents that are inconsistent with this bulletin are hereby amended, modified, and superseded accordingly.
