

AN ORDINANCE CANCELING THE TRIMOBILE FRANCHISE OF THE OPERATORS WHO FAILED TO RENEW THEIR FRANCHISE FROM 2018 AND EARLIER, WITHDRAWING THE SLOTS ALLOCATED TO THEM AND DECLARING THE SAME AVAILABLE FOR AWARD TO QUALIFIED APPLICANTS, AND FURTHER ADDING A REQUIREMENT FOR THE NEW APPLICATION FOR TRIMOBILE FRANCHISE IN THE CITY OF NAGA, AMENDING FOR THE PURPOSE SECTION 113 OF ORDINANCE NO. 93-049, AS AMENDED:-

Be it ordained by the Sangguniang Panlungsod of Naga, that:


**SECTION 1.** The trimobile franchise of the operators who failed to renew their franchises which expired in 2018 and earlier are hereby declared cancelled, the slots allocated to them are hereby withdrawn, and further declare the same available for award to qualified applicants.

**SECTION 2.** The qualifications of the applicants for trimobile franchise as set forth under Section 113 of Ordinance No. 93-049, as amended, are hereby adopted with the further qualification requirement of a **copy of the latest utility bill as proof of residency for new applicants**, amending for the purpose Section 113 of Ordinance No. 93-049, as amended. 

**SECTION 3.** The Committee on Transport of the Sangguniang Panlungsod shall determine the manner and the guidelines in the award of the franchises made available by the aforesaid cancellation.

**SECTION 4.** The list of the canceled franchise prepared by the Trimobile Task Force, as reviewed and verified by the Committee on Transport of the Sangguniang Panlungsod, shall form an integral part of and is hereby annexed to this ordinance for purposes of reference.

CRANZMS

**SECTION 5.** The Naga City Public Safety Office (PSO) and the Naga City Police Office (NCPO) are hereby mandated to cause the retrieval of the city issued sidecar number of the herein trimobile units, turn-over the same to the Trimobile Task Force for proper recording, and submit to the Sangguniang Panlungsod weekly reports on their activities to effect this mandate until it is completed. 

**SECTION 6.** This ordinance shall take effect upon its approval and publication in the newspaper of local circulation and posting in City Government bulletin boards.






