EXPLANATORY NOTE

The City Government of Naga believes that health is wealth.

The ongoing journey of Naga into a modern and welfare city in the next 25 years toward its first centennial and its vision for a happy city and an assured Nagueños necessarily is a vision for a healthy constituency.

The City Health Office (CHO) is the primary agency of the city government that implements its policies and programs to promote and ensure the health of its people.

The CHO, however, is addressing volumes of client issues on a daily basis. This regular service point situation is stressful to both CHO personnel and clients which more oftentimes results to dissatisfaction on both sides, or worse, to failure of service delivery. This situation is an anathema to the City Government renowned good governance and the people's collective aspiration for a healthy citizenry.

The establishment of City Health Office II is therefore an essential and strategic response to this concern. The selection of the location at the new Sta. Cruz Development Site is consistent with the thrust of the present city administration to bring the government closer to the people. Thus, this ordinance.

AN ORDINANCE ESTABLISHING THE CITY HEALTH OFFICE II AT THE NEW STA. CRUZ DEVELOPMENT SITE, BARANGAY STA. CRUZ, NAGA CITY, AND MANDATING THE PROVISION OF AN ANNUAL APPROPRIATION FOR ITS OPERATION IN THE ANNUAL BUDGET OF THE CITY GOVERNMENT OF NAGA: -

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. ESTABLISHMENT. - There is hereby established an office which will form an organic part of the City Health Office of the City Government of Naga to be known as City

Health Office II at the New Sta. Cruz Development Site, Barangay Sta. Cruz, Naga City.

SECTION 2. PURPOSE. - The purpose of the establishment of the City Health Office II is to decongest the operation of the City Health Office and to bring the health services of the City Government of Naga closer to the people, especially among the residents of Barangays Sta. Cruz, Abella, Igualdad, Sabang, Bagumbayan Sur, and other adjacent barangays in the City of Naga.

SECTION 3. SERVICES AND FACILITIES. - City Health Office II is an extension service facility and thereby offers the same and complements the services of the City Health Office. That services and facilities to include:

1. Medical consultation and checkups
2. Immunization
3. Prenatal/postnatal/postpartum
4. Laboratory
5. Dental
6. Animal Bite and Treatment Center
7. Reproductive health and wellness (STI, HIV, and AIDS)
8. Tropical diseases
9. Health and sanitation (sanitary permits, inspections)
10. Cardiovascular
11. Issuance of health certificates
12. Review of death certificates
13. Issuance permits (cadaver transfer, cremation)
14. Medico-legal
15. Infectious diseases services (TB/leprosy)
16. Other related services

SECTION 4. PERSONNEL AND STRUCTURE. - The City Health Officer is hereby mandated to develop the personnel and manpower structure of City Health Office II and submit the same to the Sangguniang Panlungsod for review and approval.

SECTION 5. FUNDING AND TRANSITION. - The City Health Officer shall constitute the personnel organization of the City Health Office II, utilizing its current organic personnel to operationalize the new office until such time that its organizational structure is approved and its personnel are hired and appointed.

The cost of the operation of the new office for the current year shall be taken from the current appropriation of the City Health Office. Supplementary appropriation, whenever necessary and source of fund is identified, shall be provided upon approval by the Sangguniang Panlungsod. Appropriations

in the ensuing years shall be provided in the annual budget of the City Government of Naga.

SECTION 6. REPEALING CLAUSE. - All ordinances, executive orders, and other issuances inconsistent with the provisions of this ordinance are hereby deemed repealed amended, or modified or modified accordingly.

SECTION 6. EFFECTIVITY. - This ordinance shall take effect upon its approval and publication in the newspaper of local circulation and posting in City Government bulletin boards.




