WHEREAS, Article II, Section 13 of the Philippine Constitution mandates the recognition the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, the recognition of City Persons with Disability Youth Association through a resolution will not only give them a formal status but also provide a framework for their activities and initiatives aligned to the goals and thrusts of Naga City's Persons With Disability Affairs Office and Naga City Youth Development Office;

WHEREAS, the key objectives of the resolution are as follows:

1. Recognition: Officially recognizing the Naga City Persons with Disability Youth Association as a legitimate and important organization within the city;
2. Empowerment: Providing the association with the necessary support and resources to carry out their activities effectively, including access to information, training programs, and funding opportunities;
3. Advocacy: Encouraging the association to actively advocate for the rights, welfare, and inclusion of youth with disabilities in various aspects of society, such as education, employment, healthcare, and accessibility;
