WHEREAS, the Philippines is one of the signatories of the Convention on the Rights of the Child which underscores the principle of child participation which refers to the right of children to actively take part in the discussions of and decision-making processes on matters and concerns that involve the children themselves;

WHEREAS, the Naga City School Board (NCSB) was created in accordance with the directive on the establishment of a local school board in every city, municipality, and province under the Local Government Code of 1991;

WHEREAS, instead of merely serving as a body mandated to allocate the Special Education Fund (SEF) as stipulated in the Local Government Code of 1991, the reinvention of the NCSB accorded to its members additional powers and responsibilities such as the preparation of the local school plan and budget;

WHEREAS, this reinvention is born out of the Local Government Unit's commitment to greater citizen participation which is an important element of good governance that Naga City is particularly known for;

WHEREAS, the composition of the Naga City School Board was constituted under Executive Order No. 2023-022;

WHEREAS, an expanded membership of the said board is constituted "to promote cooperation among all stakeholders of Naga in advancing accessible and quality education and in building a self-reliant and caring city";

WHEREAS, representation that caters to in-school youth is a vital facet in order to ensure that every major stakeholder is involved with dialogues concerning education and in order to further amplify the virtue of genuine citizen participation;

WHEREAS, the DFSSG President shall serve as the student representative wherein his/her vote shall count as one during decision-making;

WHEREAS, the term of membership of the DFSSG President shall start and end in correspondence to their term of office as the elected DFSSG President;

WHEREAS, the Naga City School Board shall meet at least once a month or as often as may be necessary, hence, in fulfillment of this role, the DFSSG President shall be excused from his/her classes during the scheduled board meeting and shall be given three (3) days to comply any missed requirements or activities during the said meeting;


