## **Bid Bulletin: Amendments to Bid Documents for the Supply and Delivery of Medicines for Naga City Hospital**

September 11, 2023

### **Project Reference No. 2023-033: Supply and Delivery of Medicines (1 Lot) (A Republication After a Failed Bidding)**

Amendments and corrections for specific items have been made:

1. Item No. 33: The item should be "Colchicine 500mcg."
2. Item No. 66: "Salbutamol 1mg/ml. 2.5ml respiratory solution" will be accepted.
3. Item No. 67: "Silver Sulfadiazine 1%, 20 grams" will be accepted.

The Approved Budget for the Contract (ABC) remains unchanged despite the upgrade option presented by interested bidders during the prebid conference.

### **Project Reference No. 2023-034: Supply and Delivery of Medicines (1 Lot) (A Republication After a Failed Bidding)**

Amendments and preference have been made for specific items:

1. Item No. 1: The preferred brand is "TETAGAM P" or a similar product approved by the Department of Health (DOH) and the World Health Organization (WHO).
2. Item No. 2: The preferred brand is "EQUIRAB" or a similar product approved by the DOH and WHO.
3. Item No. 4: The item should be "multi-dose, for pediatric use." The preferred brand is "EUVAX-B" or a similar product (e.g., GeneVAc-B).
4. Item No. 5: ARV has been removed. The preferred brand is "VAXIRAB N." Interested bidders are required to attach additional documents, such as test analysis and proof of authenticity, to ensure the product is not counterfeit.

#### **Other Important Information:**

Products must have a minimum shelf life of 18 months and a maximum shelf life of up to 3 years. A letter of guarantee confirming the specified shelf life must be submitted with the bid documents.


#### **Bid Opening Information:**

The bid opening date remains unchanged and will be held on Monday, September 25, 2023, at 3:00 PM at the City Procurement Office, Ground Floor, City Hall Building. Bids will be opened in the presence of bidders' representatives who choose to attend.

The bulletin is labeled as "Supplemental/Bid Bulletin No. 1" and forms an integral part of the original Bidding Documents. It states that any provisions in the original Bidding Documents that are inconsistent with this bulletin are hereby amended, modified, and superseded accordingly.
