AN ORDINANCE FORMALLY CONFIRMING THE NAME AND DECLARING THE EXTENT OF LEON SA AUREUS ST. FROM J. MIRANDA AVE. TO THE UNNAMED STREET TOWARD USWAG BALATAS, NAGA CITY:-

EXPLANATORY NOTE

The road now known as Leon SA Aureus St. which runs from J Miranda Ave. from Bicol Science and Technology Centrum on its western end is now further extended to the unnamed street leading to Uswag Balatas on its eastern end after the completion of the road project which improved connectivity between and communities of Naga City.

Upon verification, however, no ordinance was enacted by the Sanggunian to officially adopt that street name.

The eponym, Leon SA Aureus, was the first City Mayor of Naga appointed by President Elpidio Quirino when the city was inaugurated in 1948. Naming this street after him was a fitting recognition of his contributions to the development of the postwar Naga.

AN ORDINANCE FORMALLY CONFIRMING THE NAME AND DECLARING THE EXTENT OF LEON SA AUREUS ST. FROM J. MIRANDA AVE., CONCEPCION PEQUEÑA, TOWARD THE UNNAMED STREET LEADING TO USWAG BALATAS, BARANGAY BALATAS, NAGA CITY:-

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. STREET NAME. - It is hereby formally confirmed the name of the street from J. Miranda Ave., Concepcion Pequeña, to the unnamed street leading to Uswag Balatas, Barangay Balatas, Naga City as Leon SA Aureus.

SECTION 2. EXTENT AND COORDINATES. - The street starts from Coordinate 13.625885, 123.199690 on the western end to Coordinate 13.628222, 123.210466 on the eastern end.

SECTION 3. STREET SIGNAGE. - The City Engineer Office (CEO) and the City Event Program Protocol and Information Office (CEPPIO) are hereby mandated to install the appropriate street signage along the stretch of the street from end to end and at the intersections, subject to the provisions of existing ordinances.

SECTION 6. REPEALING CLAUSE. - All ordinances, executive orders, and other issuances inconsistent with the provisions of this ordinance are hereby deemed repealed, amended, or modified accordingly.

SECTION 6. EFFECTIVITY. - This ordinance shall take effect upon its approval.
