WHEREAS, received by the Sangguniang Panlungsod for appropriate action is copy of Resolution No. 506 of the Sangguniang Bayan of Sipocot, Camarines Sur, entitled: "Resolution respectfully requesting the City Government of Naga through the City mayor, Honorable Nelson S. Legacion to consider the Municipality of Sipocot, Camarines Sur for an Inter-LGU Partnership or Sisterhood Program;

WHEREAS, the establishment of sisterhood relationship is necessary in order that both local government units and their constituents can come up with a joint program of planned and continuous contracts among themselves and bring together both municipal and voluntary community resources and offer a mechanism for individuals and organizations to be involved in the field of friendly relations, understanding and goodwill;

WHEREAS, the establishment of a city sisterhood will serve as a strong foundation for friendly ties between the City Government of Naga and the Municipal Government of Sipocot;

NOW, THEREFORE, on motion of Hon. Jose B. Perez, seconded by Hon. Jessie R. Albeus, Hon. Melvin Ramon G. Buenafe and Hon. Jose C. Rañola;

BE IT RESOLVED, as it is hereby resolved, to accept the offer of the Municipal Government of Sipocot, Camarines Sur for an Inter-LGU Partnership or Sisterhood Program with the City Government of Naga.
