RECONSTITUTING THE TECHNICAL WORKING GROUP FOR THE FORMULATION OF THE NAGA CITY COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM FOR CY 2024-2028

WHEREAS, the Naga City Comprehensive Local Juvenile Intervention Program (CLJIP) is an inter-agency and multisectoral action plan of the Local Government of Naga that serves as the city’s comprehensive guide in the implementation of various intervention and diversion programs for the protection, rehabilitation, and reintegration of Children at Risk (CAR) and Children in Conflict with the Law (CICL), to their respective families and the community;

WHEREAS, the present CLJIP of the city covers the period from CY 2021 to CY 2023;

WHEREAS, a subsequent CLJIP must be formulated to ensure continuity of the implementation of the program and the integration of necessary additional provisions for the proper handling, care, and management of CAR and CICL cases;

WHEREAS, there is a need to reconstitute the Technical Working Group (TWG) for the formulation of the Naga City CLJIP for CY 2024-2028;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

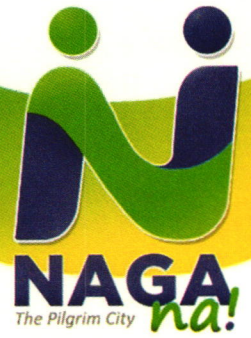

SECTION 2. SECRETARIAT. The Children's Affairs Office shall serve as the Secretariat of the TWG for the formulation of the Naga City CLJIP for CY 2024-2028

SECTION 3. FUNCTIONS. The TWG and the Secretariat shall have the following tasks and responsibilities:

- a. Facilitate the gathering of data and coordination with concerned offices and organizations
- b. Formulate the Situational Analysis
- c. Recommend necessary revisions
- d. Consult with the NCCWPC on the results and outputs
- e. Ensure the submission of CLJIP to RJJWC, DILG, and CWC
- f. Facilitate the conduct of monitoring and evaluation of the Programs, Projects, and Activities (PPAs) in the CLJIP
- g. Perform other duties as may be necessary in the attainment of the goals and objectives of the CLJIP

SECTION 4. MONITORING AND EVALUATION. An annual monitoring and evaluation activity shall be set forth by the committee, to be attended by the current permanent alternate of the represented office, and with the Children Affairs Office to serve as the Secretariat.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately.
