WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated December 6, 2023 from His Honor, the City Mayor endorsing for ratification the Deed of Donation entered into by and between the City Government of Naga and Packetworx, Inc. relative to the donation of various devices to the City Government of Naga;

WHEREAS, through Resolution No. 2023-498, the Sangguniang Panlungsod granted the Honorable City Mayor the authority to enter into the said Deed of Donation, subject to the ratification by the Sangguniang Panlungsod;



DEED OF DONATION

KNOW ALL MEN BY THESE PRESENTS:


This Deed of Donation, made and executed in the City of Naga, Philippines, by **PACKETWORX, INC.**, represented by its Chief Marketing Officer (CMO), **MARIA RAISA HELGA YSAAC-ORBON**, with office address at GF iSquare Bldg. 15 Meralco, Pasig City and **THINGSPH, INC.**, with office address at Loft Office, One Corporate Center, Pasig City represented by its Chief Executive Officer (CEO), **FERDINAND YANTO III**, hereinafter called the "DONORS"

- IN FAVOR OF -

The **CITY GOVERNMENT OF NAGA**, herein represented by its Mayor, **HON. NELSON S. LEGACION**, as authorized by Sangguniang Panlungsod Resolution No. 2023-498, with office address at City Hall Compound, J. Miranda Ave., Concepcion Pequeña, Naga City.

- WITNESSETH -

- 1) That the DONORS are the owner LoRaWan gateways, provider of LoRaWan network and supplier of LoRaWan enabled IOT devices.
- 2) That for and in consideration of the DONORS' altruistic desire to give back and help the nation in terms of IOT development, the said DONORS, by these presents, transfer and convey, by way of donation, unto said DONEE, its heirs and assigns, the following properties, free from all liens and encumbrances:
 - a) Three (3) units of packetSENSE Ultrasonic Proximity Sensor 4meters;
 - b) Three (3) units of packetSENSE Submersible Level;
 - c) Two (2) units of packetSENSE Rainfall;
 - d) Free Use of LoRaWan Network in relation to the above donated devices; and
 - e) Free Use of ThingsPH dashboard in relation to the above donated devices.
- 3) That the DONORS do hereby state, for the purpose of giving full effect to this donation, that it has reserved for itself in full ownership of sufficient property to support it in a manner appropriate to its business needs and operations;
- 4) That the DONORS and the DONEE recognize that the donation of the above properties shall be solely used for the following purpose:
 - a) Acquire data and information to be used to support any proposal for the City's infrastructure projects;
 - b) Acquire data and information to study, review and curate certain operational and management policies related to security, safety, risk and management, personnel management, asset management and such other aspects of governance;
 - c) The data and information acquired from LoRaWan devices herein donated shall not be used for personal or commercial purposes.
- 5) That the DONORS hereby impose, and which the DONEE accepts the following conditions of the Donation:
 - a) the DONEE shall, in cooperation with the DONORS' personnel, identify and make available agreed locations for the installation and establishment of the LoRaWan Gateway/s to enable the LoRaWan network necessary to support the use and purpose of the donated devices;
 - b) the DONEE shall, in cooperation with the DONORS' personnel, identify and make available agreed locations for the installation and operation of donated packetSENSE devices;



- c) the DONEE shall be responsible for acquiring all necessary permits, licenses or authority related and necessary to the valid and legal installation of the LoRaWan Gateways for a period of at least 15 years;
 - d) the DONEE shall be responsible for acquiring all necessary permits, licenses or authority related and necessary to the valid and legal installation of packSENSE devices;
 - e) the DONEE shall ensure that the LoRaWan Gateway/s and packetSENSE devices are secure and safe in their respective locations;
 - f) the DONEE shall immediately notify Packetworx of any damage or irregular functions of the gateway/s or packSENSE devices and, together, the DONEE and DONORS's personnel shall resolve said issues;
 - g) the DONEE recognizes that while all data/information gathered from the donated devices are accessible and available for reasonable and exclusive governmental use by the local government, the ownership of such data remains with the DONORS; and
 - h) the DONEE shall also ensure that all data/information shared to it follows all data privacy regulations in the country.
- 6) That the DONEE, upon a resolution issued by its Sangguniang Panlungsod, hereby accepts this donation of the above-described properties, and does hereby express gratitude for the kindness and liberality of the DONORS.
