

Resolution Declaring LCRB and Recommending Approval


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- b) To recommend for approval by the City Mayor of the City Government of Naga the foregoing findings.





CONTRACT AGREEMENT

THIS AGREEMENT, made this APR 18 day of 2024 between City Government of Naga, Naga City, Philippines (hereinafter called the "Entity") and Power Compact Enterprises of 41-C Mayon Avenue, Naga City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Power Supply at Sta. Cruz High School, Bgy. Sta. Cruz, Naga City, Contract Reference Number 009251-0000-00 (hereinafter called "the Works") and the Entity has accepted the Bid for Four Million Fifty Thousand One Hundred Sixty Three & 86/100 (P 4,050,163.86) Pesos by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2015 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:


- a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conformance thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Four Million Fifty Thousand One Hundred Sixty Three & 86/100 (P 4,050,163.86) Pesos or such other sums as may be ascertained, Power Compact Enterprises agrees to Construct the Power Supply at Sta. Cruz High School, Bgy. Sta. Cruz, Naga City, Contract Reference Number: 009251-0000-00, in accordance with his/her/its Bid.
4. The City Government of Naga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
