\*THIS AGREEMENT, made this \_\_\_\_\_\_ day of ADD 1 6 2024 between City Government of Naga, Naga City, Philippines (hereinafter called the "Entity") and St. Bernardine Construction And Enterprises of 0677 Zone 5, Maleniza Compound, Bgy. San Felipe, Naga City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Construction of Twin Stage Phase 1 at Liboton Annex, Camarines Sur National High School, Bgy. Liboton, Naga City, Contract Reference Number: 009294-2024-01 (hereinafter called "the Works") and the Entity has accepted the Bid for One Million Four Hundred Ninety Thousand (P 1,490,000.00) Pesos by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
