CONTRACT AGREEMENT

THIS AGREEMENT made this 24th day of JAN 2024 between **City Government of Naga, Naga City, Philippines** (hereinafter called the "Entity") and **Jomasan Construction And Supply** of 2nd St. Doña Clara Village, Bgy. Concepcion Pequeña, Naga City (hereinafter called the "Contractor")

WHEREAS, the Entity is desirous that the Contractor execute **Drainage at Misercordia St., Bgy. Tinago, Naga City, Contract Reference Number: 009322-2024-01** (hereinafter called "the Works") and the Entity has accepted the Bid for **Four Hundred Seventy Nine Thousand Five Hundred (P 479,500.00) Pesos** by the Contractor for the execution and completion of such Works and the remedying of any defects therein

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation

- c. Performance Security
- d. Notice of Award of Contract and the Bidder's conforme thereto, and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Four Hundred Seventy Nine Thousand Five Hundred (P 479,500.00) Pesos** or such other sums as may be ascertained, **Jomasan Construction And Supply** agrees to Construct the **Drainage at Misercordia St., Bgy.
