## ORDINANCE NO. 2024-032

AN ORDINANCE SETTING THE NEW GUIDELINES FOR THE IMPOSITION OF FEES IN THE BICOL CENTRAL STATION (BCS):-

Sponsor: Hon. Salvador M. Del Castillo

SECTION 1. PURPOSE. This ordinance is enacted to ensure the viability and sustainability of the operation of the Bicol Central Station of the City Government of Naga as a Local Economic Enterprise established under City Ordinance No. 2018-065 and to sustain its contribution to the growth of the local revenue of the City Government of Naga.

**SECTION 2. OBJECTIVE.** This ordinance is enacted to set the new guidelines that shall govern the imposition of fees in the Bicol Central Station, specifically, the assessment of terminal fees and other fees for the use of its facilities.

### SECTION 3. DEFINITION OF TERMS.

- 1. Inter-regional buses. Are buses with point of origin or final destinations beyond Bicol Region.
- 2. Originating buses. Are buses which initial point of origin is Naga City, or if at the time of parking at the Bicol Central Station, it has no passengers.
- 3. Pick-up buses. Are those originating outside Naga City which passes thru with more than five (5) passengers on board and loaded less than one-half of the seating capacity and do not stay at the loading bays for more than thirty (30) minutes. However, if the bus stayed more than one (1) hour, the bus will be considered originating.
- 4. Pass-thru buses. Are those which only unload passengers at the terminal without loading any passengers.
- 5. Provincial buses. Are buses with final destination beyond Naga City but within Camarines Sur (Intra-Province), and beyond Camarines Sur but within Bicol Region (Inter-Province).

SECTION 5. Buses coming from outside Naga which intend to pick-up passengers at the Bicol Central Station may be considered originating and shall be assessed accordingly if:

- 1. They have five (5) and below number of passengers. Or
- 2. Were able to solicit a number of passengers equivalent to one-half or more of the bus seating capacity

**SECTION** 6. Pick-up buses staying more than one (1) hour shall be considered originating and will be assessed accordingly.

SECTION 7. Pass-thru buses which only unload passengers at the terminal without loading any passenger shall be exempt from terminal fee, provided that their stay at the unloading bays does not exceed five (5) minutes to give way to other pass thru buses. Provided, further, that should they pick-up passengers, or stay in the terminal for at least thirty (30) minutes, the bus will be considered as pick-up bus and will be assessed accordingly.

**SECTION** 8. Interval time for intra- and inter-province buses shall be disregarded if the bus is at full seating capacity before the allotted minutes of stay at the loading bay.
