BID BULLETIN: REVISIONS AND AMENDMENTS TO THE INVITATION TO BID (ITB) FOR THE SUPPLY, DELIVERY AND INSTALLATION OF BACKUP ENTERPRISE, PROXY AND IMMUTABLE SERVERS AND OTHER ICT EQUIPMENT (2 LOTS) UNDER CRN 2024-036

To all prospective bidders, this Bid Bulletin is hereby issued to reflect the revisions and amendments discussed during the Pre-Bid Conference held on October 21, 2024. These changes form part of the bidding documents and are to be considered in the preparation of bids.

1. Project Presentation

Engr. Elmer Claveria Jr., representative of the Information Technology Office (ITO), presented the project details to the Bids and Awards Committee (BAC) and the prospective bidders, focusing on the deployment and important components of the ICT equipment.

2. Revisions to the Invitation to Bid (ITB)

The following items have been revised as follows:

Lot 1, Item No. 3

- **Hard Drive:** Should be **4 units** of 16TB Hard Drive SATA ISE 6Gbps 7.2K 512e 3.5" Hot-Plug, AG Drive, not 1 unit as previously indicated.
- **Front PERC Mechanical Parts:** Should be 1 unit, not 4 units, as previously indicated.
- **Hot-Plug, Redundant Power Supply (1+1), 600W MM:** Should be **1 pc**, not 2 pcs.
- **Power Cord-C13, 3M, 125V, 15A:** Should be **2 pcs**, not 1 pc.

4. Services: Extended Service: Pro Support and Next Business Day Onsite Service – ACDTS Extension, **24 Months**

1. The bidder must be a **certified VEEAM partner** and must provide a **certified VEEAM Engineer**.
2. The bidder must be a certified partner of **Dell, VEEAM, Vertiv Liebert, Aruba, Synology, Panduit, Asus, Logitech, Ubiquity, and Epson**.
3. On the **Service Level Agreement (SLA)**: Must provide **8 AM – 5 PM remote support (1 Year)** with unlimited email, chat, support, and calls.


