CRN 2024-035: Supply and Delivery of Food Commodities (1 Lot)

CRN 2024-037: Supply and Delivery of Food Commodities (1 Lot)

This bid bulletin serves to highlight the key points and specifications for the supply and delivery of food commodities under CRN 2024-035 and CRN 2024-037.

CRN 2024-035: Supply and Delivery of Food Commodities (1 Lot)

1. **Compliance with Specifications**

The procuring unit emphasized that **all technical specifications** must be strictly followed as outlined in the Invitation to Bid. Bidders are advised that non-compliance may result in disqualification.

2. **Eco-bag Requirements**

The eco-bags for this procurement should be **large** and bear the **Naga Na!** logo, as indicated in the specifications.

3. **Delivery Schedule and Location**

The delivery is scheduled for **Week 2 of November 2024** and the delivery location will be the **Office of the Senior Citizens Affairs**.

CRN 2024-037: Supply and Delivery of Food Commodities (1 Lot)

1. **Well-Milled Rice Repacking**

The well-milled rice should be repacked into **2-kilogram packs**, with a total of **23,545 packs** to be delivered.

2. **Eco-bag Requirements**

As with CRN 2024-035, the eco-bags must be **large** and bear the **Naga Na!** logo.

3. **Preferred Items and Brands**

The procuring unit has provided guidance on the preferred brands for the food items, though equivalent brands of similar quality will be accepted:

- a. **Cheese:** 165 grams, preferably **Eden** or equivalent brand.
- b. **Spaghetti Combo Pack:** 800 grams of spaghetti noodles and 1 kg of spaghetti sauce, preferably **Sunshine** or equivalent brand.
- c. **Corned Beef:** 150 grams, acceptable brands include **CDO**, **Lucky 7**, or **Argentina**.

4. **Delivery Schedule and Location**


The delivery is also set for **Week 2 of November 2024**, with the delivery location at the **Sta. Cruz Event Center**. A **one-time delivery** is preferred to ensure efficient logistics.

5. **Expiry Date of Food Items**

All food products must have a **best-before date** of **June 25, 2025**, or later.
