



EXECUTIVE ORDER NO. 065

**DIRECTING THE TEMPORARY CLOSURE AND NO-PARKING DIRECTIVE
ALONG A PORTION OF MAGSAYSAY AVENUE FOR THE IMPLEMENTATION
OF MAGSAYSAY CARLESS SUNDAYS**

WHEREAS, Section 21(c) of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, authorizes the Local Chief Executive to temporarily close streets and thoroughfares for athletic, cultural, civic, and other public activities;

WHEREAS, Section 10 of City Ordinance No. 2017-030 declares the month of November as *Bicycle Month* in Naga City and mandates the observance of *Less Car or Carless Days* in designated city streets;

WHEREAS, the City Government of Naga supports initiatives promoting active mobility, road sharing, environmental sustainability, and the creation of safe public spaces for pedestrians and cyclists;

NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of the City of Naga by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. TEMPORARY CLOSURE OF A PORTION OF MAGSAYSAY AVENUE. The Naga City Police Office (NCPO) and the Public Safety Office (PSO) are hereby directed to cause the temporary closure of Magsaysay Avenue, specifically the portion from the junction of Park Street up to the junction of Balatas Road, on November 16, 23, and 30, 2025 (all Sundays), from 5:00 P.M. to 11:00 P.M., to give way to activities connected with the implementation of Magsaysay Carless Sundays.

SECTION 2. NO-PARKING DIRECTIVE. Parking of vehicles on the roadway, shoulders, and sidewalks of the affected portion of Magsaysay Avenue shall be strictly prohibited from 4:00 P.M. to 11:00 P.M. on the aforementioned dates to ensure the safe and unobstructed use of the area by pedestrians, cyclists, and event participants.

SECTION 3. COORDINATION AND IMPLEMENTATION. All concerned offices and units are hereby instructed to coordinate closely to ensure public safety, efficient

traffic management, and the orderly conduct of the activities related to Magsaysay Carless Sundays.

The Naga City Police Office, Public Safety Office, City Events Protocol, and Public Office, City Environment and Natural Resources Office/Bike Board, and other relevant offices shall extend all necessary assistance.

SECTION 4. AMENDMENTS AND INTERPRETATION. This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

SECTION 5. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
