



EXECUTIVE ORDER NO. 2025-003

REORGANIZING AND EXPANDING THE MEMBERSHIP OF THE NAGA CITY DISASTER AND RISK REDUCTION MANAGEMENT COUNCIL (NCDRRMC)

WHEREAS, Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," mandates Local Government Units (LGUs) to organize and maintain Local Disaster Risk Reduction and Management Councils (LDRRMCs) to oversee disaster preparedness, mitigation, response, and recovery;

WHEREAS, Naga City is committed to strengthening its disaster risk reduction and management (DRRM) capabilities by ensuring a multi-sectoral and participatory approach to DRRM;


WHEREAS, the changing climate and emerging risks necessitate the expansion of the NCDRRMC membership to include key stakeholders and sectoral representatives for a more comprehensive and inclusive DRRM approach;

NOW, THEREFORE, I, NELSON S. LEGACION, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION OF THE NCDRRMC. The Naga City Disaster and Risk Reduction Management Council (NCDRRMC) shall be composed of the following:

SECTION 2. POWERS AND RESPONSIBILITIES OF THE NCDRRMC

- Approve, monitor and evaluate the implementation of the LDRRMPs and regularly review and test the plan consistent with other national and local planning programs;
- Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
- c. Recommend the implementation of forced or preemptive evacuation of residents, if necessary;


SECTION 3. RESPONSIBILITIES OF KEY OFFICIALS

- 1. Chairperson (City Mayor)
 - a. Preside over meetings of the NCDRRMC.
 - b. Approve and sign all policies, programs, and resolutions of the council.
- 2. Co-Chairperson (City Vice Mayor)
 - Assist the Chairperson in the overall coordination and supervision of council activities.
 - b. Preside over meetings in the Chairperson's absence or incapacity.
- 3. Vice-Chairperson (Administrator)
 - Assist the Chairperson and Co-Chairperson in the overall coordination and supervision of council activities.
 - Preside over meetings in both chairperson or vice-chairperson's absence or incapacity.

SECTION 4. SECRETARIAT. The NCDRRMC Secretariat shall be headed by the City Disaster Risk Reduction and Management Officer (CDRRMO). The Secretariat shall have the following responsibilities:

- a. Prepare and disseminate notices, agenda, and minutes of meetings.
- b. Maintain official records of the council.







- c. Provide administrative and logistical support to the NCDRRMC.
- d. Monitor and report the progress of DRRM programs and activities.

SECTION 6. REPEALING CLAUSE. All previous executive orders or issuances inconsistent with this order are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately upon its signing.
