**RECONSTITUTING THE NAGA CITY SCHOOL BOARD**

**WHEREAS**, Section 98 of Republic Act No. 7160 mandates the creation of a local school board;

**WHEREAS**, the City Government of Naga has reinvented the Naga City School Board by expanding its membership to include representatives from private sectors, and from the Naga City People's Council, the umbrella organization of all non government and people's organizations in Naga.

**WHEREAS**, due to changes in existing circumstances, there is a need to reconstitute the Naga City School Board;

**NOW THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. NAGA CITY SCHOOL BOARD.** The Naga City School Board is hereby reconstituted with the following composition:

**SECTION 3. SECRETARIAT.** The Education, Scholarships, and Sports Office shall serve as Secretariat of the Naga City School Board.

**SECTION 4. AMENDMENTS AND INTERPRETATION.** This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

**SECTION 5. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 6. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 7. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
