### RECONSTITUTING THE NAGA CITY DISASTER AND RISK REDUCTION MANAGEMENT COUNCIL

WHEREAS, Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010" mandates Local Government Units (LGUs) to establish, organize and maintain a Local Disaster Risk Reduction and Management Council (LDRRMC) to oversee disaster preparedness, mitigation, response, and recovery;

WHEREAS, Naga City is committed to strengthening its disaster risk reduction and management (DRRM) capabilities by ensuring a multi-sectoral and participatory approach to DRRM;

WHEREAS, the changing climate and emerging risks necessitate the expansion of the NCDRRMC membership to include key stakeholders and sectoral representatives for a more comprehensive and inclusive DRRM approach;

**NOW THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. COMPOSITION OF THE NCDRRMC.** The Naga City Disaster and Risk Reduction Management Council is hereby reconstituted with the following composition:

### SECTION 2. POWERS AND RESPONSIBILITIES OF THE NCDRRMC

- A. Approves, monitors and evaluates the implementation of the LDRRMPs and regularly review and test the plan consistent with other national and local planning programs;
- B. Ensures the integration of disaster risk reduction and climate change adaptation into local development plans, programs, and budgets as a strategy in sustainable development and poverty reduction;
- C. Recommends the implementation of forced or preemptive evacuation of residents, if necessary.

#### SECTION 3. RESPONSIBILITIES OF KEY OFFICIALS

- A. Chairperson
  - 1. Presides over meetings of the NCDRRMC
  - Approves and signs all policies, programs, and resolutions of the council
- B. Co-Chairperson
  - Assists the Chairperson in the overall coordination and supervision of council activities
  - 2. Presides over meetings in the Chairperson's absence or incapacity

**SECTION 4. SECRETARIAT**. The NCDRRMC Secretariat shall be headed by the City Disaster Risk Reduction and Management Office (CDRRMO). The Secretariat shall have the following responsibilities:

- A. Prepares and disseminates notices, agenda, and minutes of meetings.
- B. Maintains official records of the council.
- C. Provides administrative and logistical support to NCDDRMC.
- D. Monitors and reports the progress of DRRM programs and activities.

**SECTION 5. AMENDMENTS AND INTERPRETATION.** This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

**SECTION 6. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.





**SECTION 7. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 8. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
