**CONSTITUTING AND ACTIVATING THE 2025 BAR EXAMINATIONS
 INCIDENT MANAGEMENT TEAM TO COORDINATE AND PREPARE FOR
 AND RESPOND TO ANY INCIDENTS AND EMERGENCIES THAT MAY
 ARISE DURING THE CONDUCT OF THE BAR EXAMINATIONS IN THE CITY
 OF NAGA**

WHEREAS, pursuant to Bar Bulletin No. 3, s. 2025, Naga City is one of the local testing centers for the 2025 Bar Examinations;

WHEREAS, the Bar Examinations is the qualifying licensure examinations for lawyers in the country administered and supervised by no less than the Supreme Court of the Philippines;

WHEREAS, according to the Bar Bulletin No. 1, s. 2024, the 2025 Bar Examinations will be held on September 7, 10, 14, 2025;

WHEREAS, to prepare for and respond effectively to any incident or emergency that may arise during the conduct of the Bar Examinations in Naga City, there is a need to set-up an integrated structure that will match the complexities and demands of this important event without being hindered by agency or jurisdictional boundaries;

NOW THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 2. AUTHORITY TO MOBILIZE AND DEMOBILIZE STRIKE TEAMS.

To aid in the expeditious performance of their tasks, the Naga City Bar IMT is hereby empowered to create and disband Strike Teams.



The IMT may tap the offices and utilize resources of the city government as needed in its tactical and strategic operations in ensuring that the conduct of Bar Examinations 2025 is orderly and peaceful.

SECTION 3. CLOSE COORDINATION WITH THE OFFICE OF THE BAR CHAIRPERSON AND THE HOST COORDINATION COMMITTEE. The Naga City Bar IMT must at all times acknowledge that the conduct of the Bar Examinations stems from the Constitutional power of the Supreme Court to supervise admissions to the practice of law and, thus, must always coordinate closely with the Office of the Bar Chairperson and the Host Coordination Committee in the conduct of their operations, to wit:




SECTION 5. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.


