**CONSTITUTING THE NAGA CITY YOUTH OFFICIALS (CYO) 2025
EXECUTIVE COMMITTEE (EXECOM)**

WHEREAS, the City Government of Naga remains committed to empowering the youth by providing opportunities for leadership and civic engagement through the annual selection and appointment of Naga City Youth Officials (CYO);

WHEREAS, City Ordinance No. 2024-063, authored by Hon. Jefson Romeo B. Felix, amends the composition of the CYO Executive Committee (ExeCom), the primary body tasked to oversee and implement the selection process of City Youth Officials in a fair, inclusive, and transparent manner;

WHEREAS, the Executive Committee is constituted for the purpose of managing the CYO selection process, including the formulation of guidelines, supervision of screening procedures, and ensuring compliance with all existing ordinances and policies governing the CYO Program;

WHEREAS, the Naga City Youth Development Office (NCYDO) shall serve as the official Secretariat of the CYO Executive Committee, providing administrative and technical support throughout the conduct of the selection process;

NOW, THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION. The following members are hereby appointed to compose the Naga City Youth Officials (CYO) 2025 Executive Committee:

SECTION 2. FUNCTIONS. The CYO ExeCom shall have the following functions:

1. Formulate and approve implementing guidelines for the CYO 2025 Selection Process;
2. Oversee and supervise the implementation of the application, examination, and interview processes;

3. Validate eligibility and screen qualified applicants;
4. Ensure compliance with all existing ordinances and policies related to the selection of City Youth Officials;
5. Coordinate with relevant offices, institutions, and stakeholders in the performance of its mandate;
6. Endorse the final list of selected City Youth Officials for 2025 to the Office of the City Mayor.

SECTION 3. SECRETARIAT. The Naga City Youth Development Office (NCYDO) shall serve as the official Secretariat of the Executive Committee. It shall be responsible for all necessary documentation, coordination, logistical arrangements, and communications essential to the efficient and effective implementation of the selection process.

SECTION 4. COMMITTEE OFFICERS. The Executive Committee shall elect a Chairperson and Vice-Chairperson from among its members, who shall serve for the duration of the CYO 2025 Selection Process and preside over meetings and deliberations accordingly. A meeting shall be convened following the issuance of this Executive Order to formally initiate the committee's work and conduct the election of its officers.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately upon approval.
