**UPDATING THE MEMBERSHIP OF THE NAGA CITY PEÑAFRANCIA
JOINT OPERATIONS CENTER EXECUTIVE COMMITTEE**

WHEREAS, Executive Order No. 020 s. 2025, activated the Naga City Peñafrancia Joint Operations Center to develop an effective and efficient system of command, control, coordination, collaboration and communication for the Festivity;

WHEREAS, it has become necessary to amend the composition of the Joint Operations Center Executive Committee to reflect current exigencies.

NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me under existing laws, do hereby order the following:

SECTION 2. AMENDMENTS AND INTERPRETATION. This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

SECTION 3. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
