**RECOGNIZING THE CHILD REPRESENTATIVES IN THE BARANGAY
COUNCIL FOR THE PROTECTION OF CHILDREN OF THE 27 BARANGAYS
IN NAGA CITY**

WHEREAS, The Philippines' national policy on child participation is rooted in the 1987 Constitution, the Convention on the Rights of the Child (CRC) particularly Article 12 which states that children have the right to express their views freely in all matters that affect them, and these views should be given due weight according to their age and maturity. This means children should be listened to and taken seriously in decisions affecting them;

WHEREAS, cited in Article 38 of Ordinance 2018-055 otherwise known as the Naga City Local Code for Children, the Barangay Children's Organization and its Federation, the Naga City Council for the Welfare and Protection of Children (NCCWPC) and the 27 Barangay Councils for the Protection of Children (BCPC) shall organize a Barangay Children's Organization. The organization primarily aims to group the children and plan programs for the children and plan programs for the promotion and protection of child's rights and welfare as well as to hear their own sentiments on the program for children;

WHEREAS, the Barangay Children Organization will form into a Federation and the President of the Federation of the FBCO shall serve as the Child Representative to the NCCWPC;

WHEREAS, the elected Child Representative shall be a member of the Barangay Council for the Protection of Children (BCPC) which roles include such as but not limited to policy-making, attendance to regular meetings of the BCPC, and so forth;

NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me under existing laws, do hereby order the following:

SECTION 4. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
