**EXECUTIVE ORDER NO. 075**

**RECOGNIZING THE CHILD REPRESENTATIVES IN THE NAGA CITY  
COUNCIL FOR THE WELFARE AND PROTECTION OF CHILDREN**

**WHEREAS**, The Philippines' national policy on child participation is rooted in the 1987 Constitution, the Convention on the Rights of the Child (CRC) particularly Article 12 which states that children have the right to express their views freely in all matters that affect them, and these views should be given due weight according to their age and maturity. This means children should be listened to and taken seriously in decisions affecting them;

**WHEREAS**, cited in Article 38 of Ordinance 2018-055 otherwise known as the Naga City Local Code for Children, the Barangay Children's Organization and its Federation, the Naga City Council for the Welfare and Protection of Children (NCCWPC) and the 27 Barangay Councils for the Protection of Children (BCPC) shall organize a Barangay Children's Organization. The organization primarily aims to group the children and plan programs for the children and plan programs for the promotion and protection of child's rights and welfare as well as to hear their own sentiments on the program for children;

**WHEREAS**, the President of the Barangay Children's Organization shall serve as the child representative to the BCPC;

**WHEREAS**, during the celebration of the 33<sup>rd</sup> National Children's Month on November 2025, as part of the activities for Children, a Congress was organized and has been attended by Child Representatives of the 27 Barangays and the PWD Children's Organization;

**WHEREAS**, the Children's Congress served as an assembly and platform for all Child Representatives to elect the organization's president and representative to the Naga City Council for the Welfare of Children;

**WHEREAS**, Joenard Querben V. Agullana, 15 years old, and Child President of Panicuason Children's Organization was hereby elected as the new President of the Naga City Children's Federation (NCC-Fed).

**WHEREAS**, recognizing the other child representative in the Local Council for the Protection of Children should come from an identified sector of children including but not limited to, Indigenous group, Children with Disabilities, and Out of school children;

**WHEREAS**, Gian Menard D. Paja, 14 years old, and Child Representative of Tabuco PWD Organization was hereby elected as the new President of the Federation of Naga City Children with Disabilities Organization.

**NOW THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby recognize the election of Joenard Querben V. Agullana as the new President of the Naga City Children's Federation and Gian Menard D. Paja as the new President of the Federation of Naga City Children with Disabilities Organization as the Child Representatives for the Naga City Council for the Welfare and Protection of Children;

**SECTION 2. AMENDMENTS AND INTERPRETATION.** This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

**SECTION 3. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 5. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
