

EXECUTIVE ORDER NO. 2025-007

RECONSTITUTING THE MEMBERS OF THE NAGA CITY INTER-AGENCY MONITORING TASK FORCE (IMTF) FOR THE CHILD-FRIENDLY LOCAL GOVERNANCE AUDIT (CFLGA) 2025

WHEREAS, the Child-Friendly Local Governance Audit is a resultsbased assessment tool and an annual mandatory audit designed to gauge the performance of City and Municipal local government units (LGUs) towards implementing programs and instituting measures to ensure the well-being of children;

WHEREAS, under the audit, local government units are guided to ensure the involvement of children in the planning, budgeting, and implementation processes of the programs, projects, and activities concerning their sector, as well as safeguard the realization of their rights to survival, development, protection and participation;

WHEREAS, the City Government of Naga has been a seventh-time awardee of the Seal of Child-Friendly Local Governance (SCFLGA) in seeking to consistently protect the rights of the Kaakiang Nagueño;

WHEREAS, in order to sustain excellence in upholding the welfare of the Nagueno children, an Inter-Agency Monitoring Task Force (IMTF) for the CFLGA has been organized wherein identified offices and point persons work as a body toward said end;

WHEREAS, due to changes in existing circumstances and movements in the functions of the designated personnel, there is a need to reconstitute the CFLGA-IMTF;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION. The Naga City Inter-Agency Monitoring Task Force (IMTF) is hereby reconstituted to be composed of the following:

- Representative, Department of Interior and Local Government Naga City





- Co-Chair, Naga City Council for the Welfare and Protection of Children
- · Executive Director, Children Affairs Office
- · Representative, City Health Office
- · Representative, City Population and Nutrition Office
- · Representative, City Social Welfare and Development Office
- Representative, City Social Welfare and Development Office Early Childhood Care Division
- Representative, Department of Education Naga City
- · Representative, City Planning and Development Office
- · Representative, City Budget Office
- Representative, City Accountant's Office
- Representative, City Treasurer's Office
- · Child President, Naga City Children's Federation
- Representative, Civil Society Organization

SECTION 2. SECRETARIAT. The Children's Affairs Office shall serve as Secretariat of the CFLGA-IMTF.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately.
