**RECONSTITUTING THE CHAIRPERSONS AND CO-CHAIRPERSONS

NOW, THEREFORE, I, NELSON S. LEGACION, City Mayor of Naga, by virtue of the powers vested in me by law, do hereby order the formal affirmation of the selection of the Chair and Co-Chair for the various CDC Sectoral Committees.

SECTION 1. AFFIRMATION OF SELECTION – The selection of the above-listed individuals as Chair and Co-Chair of their respective CDC Sectoral Committees is hereby affirmed. They shall assume their roles and responsibilities in ensuring the effective representation and coordination of their respective committees within the CDC.

SECTION 2. DUTIES AND RESPONSIBILITIES – The designated Chair and Co-Chair shall:

1. Lead their respective committees in the formulation, evaluation, and implementation of sectoral plans aligned with the Comprehensive Development Plan (CDP) and the Annual Investment Program (AIP);
2. Represent their respective committees in CDC meetings and activities;
3. Coordinate with relevant government agencies and stakeholders to ensure the efficient execution of programs and projects; and
4. Perform other functions as may be necessary for the fulfillment of their duties.

SECTION 3. IMPLEMENTATION AND EFFECTIVITY – This Executive Order shall take effect immediately upon signing and shall remain in force unless amended or revoked.
