RECONSTITUTING THE LOCAL FINANCE COMMITTEE (LFC)

WHEREAS, Section 316 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the creation of a Local Finance Committee to assist the Local Chief Executive in the preparation of the annual budget and the determination of available financial resources;

WHEREAS, it is imperative to align the financial planning and budgeting processes with the strategic goals and objectives of the City Government, as embodied in the "Finish Lines Agenda," to ensure efficient and effective utilization of public funds;

NOW THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. LOCAL FINANCE COMMITTEE. The Naga City Finance Committee is hereby reconstituted with the following composition:

SECTION 2. FUNCTIONS. The Committee shall perform the duties and responsibilities enumerated under Section 316 of the Local Government Code of 1991, its implementing rules and regulations, and such other functions as may be necessary to effectively assist the Local Chief Executive in the preparation, execution, and monitoring of the City Government's annual budget and financial plans.

SECTION 3. SECRETARIAT. The City Budget Office shall serve as the Secretariat of the Committee.

SECTION 4. AMENDMENTS AND INTERPRETATION. This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

SECTION 5. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.
