EXECUTIVE ORDER NO. 015

AN ORDER ASSIGNING THE MANAGEMENT OF THE FIREARMS OF THE CITY GOVERNMENT OF NAGA TO THE PUBLIC SAFETY OFFICE AND DESIGNATING MR. RENNE F. GUMBA AS THE AUTHORIZED BONDED FIREARM CUSTODIAN THEREOF

WHEREAS, the City Government of Naga procured various types of firearms for its security purposes and currently under the custody of the General Services Department;

WHEREAS, the security of public facilities owned and maintained by the City Government as well as providing civil security assistance are within the mandate of the Public Safety Office;

WHEREAS, the Revised Implementing Rules and Regulations 2018 of RA 10591, otherwise known as "An Act Providing for a Comprehensive law on Firearms and Ammunition and Providing Penalties for Violations thereof," has provided for instructional guide for firearms and renewal process;

WHEREAS, it is imperative to ensure the proper management through the timeliness of the registration of the said firearms and promptly comply with national policies in the ownership of the said firearms;

NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. MANAGEMENT. The management of the firearms owned and maintained by the City Government is hereby assigned to the Public Safety Office.

SECTION 2. DESIGNATION. Mr. Renne F. Gumba, head of Public Safety Office, is hereby designated as the authorized bonded firearm custodian, who shall meet the standard requirements and qualifications mentioned in the Revised 2018 IRR of RA 10591. As such, he is hereby authorized to sign any and all documents for and in behalf of the City Government relative to firearms registration and compliance with national policies.

SECTION 3. FUNCTIONS AND RESPONSIBILITIES. The Public Safety Office and its head shall have the following functions and responsibilities:

- A. Perform all acts of management to ensure the proper handling and storage of the firearms;

- B. Promptly comply with national policies and directives relative to the registration, possession, and maintenance of the firearms;
- C. Ensure compliance to the requirements and qualifications of the City Government employees who are allowed to possess firearms owned by the City Government and registered under its name; and
- D. Perform such other incidental and necessary functions as directed by law, order, and ordinance.

SECTION 4. AMENDMENTS AND INTERPRETATION. This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

SECTION 5. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.


SECTION 6. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
