



**EXECUTIVE ORDER NO. 069**

**CREATING THE CITY TECHNICAL WORKING GROUP (TWG) FOR THE  
INTEGRATION OF LOCAL HEALTH SYSTEMS IN THE CITY OF NAGA**

**WHEREAS**, the City of Naga expressed its intent to implement and demonstrate the health reforms and milestones aimed by Universal Health Care (UHC) Act or Republic Act No. 11223, particularly the integration of local health systems into City-Wide Health Systems (CWHS);

**WHEREAS**, the Sangguniang Panlungsod passed Resolution No. 2025-293 dated July 8, 2025, expressing its strong support to the intent of the City Government to be part of the UHC Integration Sites (IS);

**WHEREAS**, as UHC Integration Site, the City is expected to operationalize and fully implement all local health systems reforms in the UHC Act, particularly those in relation to managerial and financial aspects of the integration of local health systems;

**WHEREAS**, Chapter V, Section 19 of the UHC Act provides that the City Health Board shall oversee and coordinate the integration of health services for City-Wide Health System (CWHS) in highly urbanized and independent component cities;

**WHEREAS** to successfully implement the UHC Act in the city, there is a need to formally constitute the composition of a Technical Working Group (TWG) that will assist the City Health Board (CHB) in the managerial, technical, and financial integration of the local health systems in the City of Naga;

**NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby create the City Technical Working Group (TWG) on Local Health Systems (LHS) Integration:

**SECTION 2: FUNCTIONS OF TWG.** The TWG shall act as an advisory committee to the CHB and undertake necessary activities pursuant to UHC Act, its Implementing Rules and Regulations (IRR), and other related national policies and guidelines, to wit:

1. Advocate for the integration of the local health systems;
2. Convene the key stakeholders in the city to discuss and agree on the need to develop a CWHS as part of ensuring quality, affordable, comprehensive, and efficient health care in the city;
3. Coordinate with the Department of Health (DOH) and other partners for health to secure assistance needed towards the institutionalization of the CWHS;
4. Assist in the conduct of preparatory works needed to facilitate the organization of the CWHS, such as mapping of the service capabilities of health facilities and services, including the status of DOH license and PhilHealth accreditation, and catchment populations; drafting of operational guidelines and other technical documents; conduct of baseline assessment, among others;
5. Assist in the managerial, technical, and financial integration of the local health systems, including the monitoring of implementation and functionality of the management support systems such as 1) strategic and investment planning; 2) human resources for health management and development system; 3) information system, including interoperable electronic medical records system among health providers; 4) epidemiology and surveillance system; 5) logistics and supply chain management; 6) functional two-way referral system; 7) disaster risk reduction management for the health system; and 8) implementation of proactive and effective health promotion programs or campaigns;
6. Recommend to the CHB the considerations for the equitable distribution of the SHF;

7. Advocate for public-private partnerships to facilitate complementation of efforts;
8. Create technical sub-committees, as deemed necessary; and
9. Perform such other functions and acts as may be necessary, proper, and incidental to the attainment of its objectives.

**SECTION 3: SECRETARIAT.** The City Health Office (CHO) shall serve as the secretariat of the TWG. They shall perform the following duties and functions:

1. To provide communication, coordination, and liaison support to all activities of the TWG;
2. To perform record management of all documents and such other functions and acts as may be necessary

**SECTION 4. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 6. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
