



EXECUTIVE ORDER NO. 029

RECONSTITUTING THE CITY DEVELOPMENT COUNCIL OF NAGA CITY

WHEREAS, the Local Government Code stipulates the creation of a Local Development Council responsible for initiating comprehensive multi-sectoral development plans;

WHEREAS, the Code additionally tasks the Local Development Council with assisting the Sanggunian in charting the course of economic and social development and coordinating such endeavors; and

WHEREAS, a reconstitution of the Naga City Development Council is necessitated by changes in its membership subsequent to the May 2025 elections;

NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of the City of Naga by virtue of the powers vested in me by law, do hereby order the reconstitution of the composition of the City Development Council, to wit:

SECTION 1. COMPOSITION. The City Development Council is hereby reconstituted and reorganized with the following composition, to wit:

SECTION 2. DUTIES AND FUNCTIONS. The CDC shall perform the following functions:

1. Formulate long-term, medium-term, and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or component authority.

SECTION 3. EXECUTIVE COMMITTEE. An Executive Committee (ExeCom) is hereby constituted, composed of the following:

1. City Mayor
2. Chairperson, SP Committee Appropriations
3. President, Liga ng mga Barangay
4. Chairperson, Naga City People's Council

The Executive Committee shall act on behalf of the Council during periods when the full Council is not in session, and may make urgent decisions consistent with the Council's mandate, subject to subsequent confirmation or ratification as may be required.

SECTION 4. SECTORAL AND FUNCTIONAL COMMITTEES. The City Development Council (CDC) shall, through a resolution, constitute sectoral and functional committees to support the performance of its duties and to facilitate the active participation of its members in the planning and implementation processes.

SECTION 5. SECRETARIAT. The City Planning and Development Office (CPDO) shall serve as the Secretariat of the CDC, including all sectoral and functional committees that may be subsequently established. The Secretariat shall provide technical and administrative support to ensure the effective functioning of the Council and its committees.

SECTION 6. MEETINGS. The City Development Council (CDC) shall convene at least once every six (6) months, while the Executive Committee (ExeCom) shall meet at least once every month. Special meetings of the CDC or the ExeCom may be called by the Chairperson or upon the request of the majority of their respective members.

SECTION 7. AMENDMENTS AND INTERPRETATION. This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

SECTION 8. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 10. EFFECTIVITY. This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
