**CREATING THE STEERING COMMITTEE FOR THE PROPER OBSERVANCE
OF THE FAMILY WEEK CELEBRATION IN NAGA CITY**

WHEREAS, the City Government of Naga recognizes the importance of the family as a basic autonomous social institution and the foundation of the nation, and thus commits itself to fortifying its solidarity and advancing its total development;

WHEREAS, Proclamation No. 60, s. 1992, declared the last week of September of every year as Family Week;

WHEREAS, the observance of Family Week provides an opportunity to highlight the role of the family in promoting values, fostering community spirit, and strengthening nation-building;

WHEREAS, there is a need to create a Steering Committee that will ensure the proper observance of Family Week and encourage wider and more active participation of the public in the activities prepared for such celebration;

NOW THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 2. FUNCTIONS AND RESPONSIBILITIES. The Naga City Family Week Steering Committee shall have the following functions and responsibilities:

1. Formulate, plan, and implement programs and activities to ensure the successful observance of Family Week;
2. Facilitate and encourage the active participation of all concerned sectors in the week-long celebration;
3. Promote public awareness of family-related issues and their impact on family members;
4. Coordinate with national government agencies, private organizations, and other stakeholders to advance the objectives of the celebration; and
5. Perform such other functions as may be necessary or incidental to the effective implementation of this Executive Order.

SECTION 3. AMENDMENTS AND INTERPRETATION. This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

SECTION 4. REPEALING CLAUSE. All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.
