



EXECUTIVE ORDER NO. 041

RECONSTITUTING THE NAGA CITY NUTRITION COMMITTEE

WHEREAS, the nutrition of the Naguenos remains a priority concern of the City Government of Naga thus ensuring that nutrition services contribute to overall health and wellbeing in alignment with sustainable development goals;

WHEREAS, the Naga City Nutrition Committee shall act as a body that shall oversee, plan and coordinate the city's programs and policies on nutrition;

WHEREAS, the said committee is composed of representatives from the private and public sectors, pursuant to the city's participatory and people-centered governance, and to ensure that all insights and means for the city to deliver efficient and effective nutrition programs are considered;

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) 2023-2028 highlights the need to reduce all forms of malnutrition across all life stages;

WHEREAS, there is a need to reorganize and expand the membership of the Naga City Nutrition Committee, to most effectively carry out its objectives, in line with the aims of the PPAN;

NOW THEREFORE, I, MARIA LEONOR G. ROBREDO, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION. The Naga City Nutrition Committee is hereby reconstituted with the following composition:
