



**EXECUTIVE ORDER NO. 064**

**CREATING THE ADVANCED NAGA FOR INNOVATION AND GOOD GOVERNANCE (ANINAG) COUNCIL AS THE CITY GOVERNMENT'S CENTRAL COORDINATING, POLICY, AND ADVISORY BODY FOR DIGITAL TRANSFORMATION AND INNOVATION GOVERNANCE**

**WHEREAS**, the City Government of Naga envisions to build an *“Open, Digital, and Participatory Naga”* under its 2028 Finish Line agenda, anchored on the goal of establishing a fully digital and SMART city;

**WHEREAS**, the City Government recognizes the importance of a coherent and coordinated governance framework to guide its digital transformation initiatives, ensure data protection, promote ethical innovation, and strengthen citizen participation;

**WHEREAS**, there is a need to institutionalize a multi-sectoral body that will oversee the development, implementation, and evaluation of digital transformation and innovation programs across city departments and partner institutions;

**NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of the City of Naga by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION.** There is hereby created the Advanced Naga for Innovation and Good Governance (ANINAG) Council, which shall serve as the City Government's central coordinating, policy, and advisory body for digital transformation and innovation governance.

**SECTION 2. COMPOSITION.** The ANINAG Council shall be composed of the following:

The Council may invite other offices, private sector representatives, or experts as resource persons, as may be deemed necessary.

**SECTION 3. FUNCTIONS.** The ANINAG Council shall have the following functions and responsibilities:

1. Recommend policies, ordinances, and executive issuances that strengthen the City's digital transformation and innovation agenda;
2. Develop and implement guidelines for vetting, screening, and pilot-testing tools and systems proposed by external technology partners;
3. Oversee the integration, upgrading, and deployment of citywide digital systems and services;
4. Design programs to improve the digital competency of LGU personnel and support digital inclusion for citizens;
5. Formulate guidelines on data management, open data access, and responsible use of artificial intelligence in government decision-making;
6. Sustain digital mechanisms that promote citizen engagement, public accountability, and participatory governance; and
7. Track measurable progress toward the 2028 Finish Lines, including service efficiency, transparency, and digital adoption metrics.

**SECTION 4. SECRETARIAT.** The MyNaga App Team, under the City Mayor's Office, shall serve as the Secretariat of the ANINAG Council and provide technical, administrative, and documentation support.

**SECTION 5. AMENDMENTS AND INTERPRETATION.** This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

**SECTION 6. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 7. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 8. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
